## Ombudsman Program

- NRS 427A.125
  - Investigate and resolve complaints on behalf of residents living in longterm care settings
  - Conduct routine access for residents in long-term care settings
  - Provide support and development for resident and family councils
  - Analyze, provide comment on and monitor the development and implementation of any federal, state or local governmental action, activity or program that relates to the protection of the health, safety, welfare and rights of recipients
  - Recommend changes to any federal, state or local governmental action, activity or program

## Skilled Nursing Resident Updates

#### Senate Bill 45 (SB 45)

- Provides increase personal needs allowance
- From \$30 to \$149
- Changes the review process
- Skilled Nursing residents
- PNA Survey conducted and presented to Legislature

## Skilled Nursing Resident Updates

#### Assembly Bill 202 (AB202)

- Provides residents and legal representatives the right to have cameras in bedrooms
- Consent needed from resident/representative
- Consent from roommate
- Notice posted outside of door
- Specific criteria for turning off camera



## Residential Facility Updates

#### **Senate Bill 298 (SB 298)**

- Provides discharge rights for residents in residential facilities for groups
- Consistency for Residential Facility for Groups contracts
- Allows an appeal process
- Compliance with the Federal Settings Rule





## Residential Facility Updates

#### Assembly Bill 414 (AB 414)

- Updates to Power of Attorney forms
- Updated Power of Attorney language
- Updated requirements for capacity evaluation








## **Top 5 Complaints**

- Discharge
  - 364 out of 415 (88%)
- Physical Abuse
  - 344 out of 890 (39%)
- Care Plan
  - 318 out of 1304 (24%)
- Medications
  - 230 out of 1304 (17%)
- Personal Property
  - 213 out of 331 (64%)
